

I. Planning Organization

The North-central Alabama Regional Council of Governments (NARCOG) was created in 1969 under Legislative Act 112 and is one of twelve (12) Councils of Governments (COG's) in the State of Alabama. The 12 COG's are members of the Alabama Association of Regional Councils (AARC), which is located in Montgomery, Alabama. The NARCOG serves a three-county region consisting of Cullman, Lawrence, and Morgan Counties and including twenty-three (23) municipalities. The NARCOG is located at 216 Jackson Street, SE in Decatur, Alabama. The map below depicts the location of the NARCOG Region.

II. The NARCOG Economic Development District and the Comprehensive Development Strategy

The NARCOG is the designated Economic Development District (EDD) for the three-county region per the Economic Development Administration (EDA). The EDD designation and an approved Comprehensive Economic Development Strategy (CEDS) qualify all counties and municipalities within our region for EDA grant assistance programs. The NARCOG continues to provide the leadership and professional staff for the preparation and maintenance of the region's CEDS, assists in the implementation strategies identified in the CEDS, and provides technical assistance to economic development organizations in the region. Ultimately, the CEDS is intended as a tool to create and retain jobs, promote a more stable and diversified local and regional economy, and improve living conditions and the quality of life for the citizens of the region.

The NARCOG CEDS is the result of a continuous regional economic development planning process in our three-county region. In 2012, the NARCOG Board approved our "Full" CEDS, which will be updated again in 2016. This is the third annual report of our EDD's five-year CEDS. Annual reports are annexes to the original plan and are intended to provide project updates, performance measurement, and current economic conditions based upon various sources of data and input. The NARCOG Board approved our 2015 CEDS Annual Report by "resolution" on September 30, 2015 (See Appendix B).

NARCOG's designation as an EDD is beneficial to our three-county region in a number of ways:

- 1. Eliminates the need for counties and municipalities to update their own individual CEDS annually to qualify for EDA funding.
- 2. The EDD is available to provide technical assistance to local governments on their economic development activities, programs, and grant applications.
- 3. Regional economic development partnerships are enhanced.
- 4. Creates potential for additional federal funding; i.e., disaster preparedness and recovery and revolving loan fund.

III. The 2015 CEDS Strategy Committee

The CEDS Strategy Committee, the entity established by the NARCOG and responsible for developing, updating, or replacing strategies in the CEDS, is the principal facilitator of the economic development planning and implementation process. According to Federal guidelines, its members should represent all major interests of the community, both private and public, to ensure that viewpoints of all segments of the community are considered and to take advantage of local skills and resources in program formulation and implementation. 

VI. Demographics and State of the Regional Economy

Population

The NARCOG Region is comprised of Cullman, Lawrence, and Morgan counties. According to the 2010 Census, the Region is inhabited by 234,235 persons, which represents an increase of over 10,000 persons. In 2000, the Region was inhabited by some 223,350 persons, which represented an increase of 10.8% over the 1990 regional population of 199,169. It is projected that the population for the Region will increase to 245,983 by 2025, which represents a relatively slight increase from 2010. County Unemployment Rates





New and Expanding Industry

The following tables reflect the number of new and expanding industries along with the corresponding amounts of capital investment and jobs created within the NARCOG EDD service area of Cullman, Lawrence, and Morgan Counties from January 1, 2015 to June 30, 2015. Thus far in 2015, there has been 12 new and expanding companies, nearly \$194M in capital investments, and 237 jobs created and/or retained. Analysis reveals that all three (3) counties in our Region experienced an increase in each of those categories this year compared to the same reporting period in 2014, especially Lawrence County. Also, these numbers provided by local economic development agencies, represent what has been "announced" during this time period and it may be several years in some cases before the actual private investment and most importantly...the jobs are actually created.



VII. Regional Economic Development Observations, Opportunities, and Trends

Industrial Parks

The NARCOG Region has some 26 industrial parks. The total available acreage is approximately 1,937 acres in Cullman County, approximately 1,083 acres in Lawrence County and only 422 acres in Morgan County. Cullman and Morgan County are both presently in the process of identifying additional acreage for future industrial development.



Revolving Loan Fund - The NARCOG operates a Revolving Loan Fund (RLF) Program intended to assist small and medium size business and industries throughout the region with gap financing. The NARCOG RLF Program has been very successful over the years and is partially funded by EDA. NARCOG's Revolving Loan Fund (RLF) was marketed in the Region by the RLF Program Coordinator and information was made available at: NARCOG, local Chambers of Commerce, industrial development associations, Decatur-Morgan County Entrepreneurial Center, local banks, all member governments, and online at www.narcog.org.

For the period October 1, 2014 through September 30, 2015 NARCOG closed three (3) loans in Morgan County for a total of \$600,000 with ARC, USDA RBEG, and Alabama Bond funds. Of note, Morgan County is currently ineligible for EDA RLF funds under the Economic Adjustment Assistance program. NARCOG conducted 30 site visits, received 7 applications, and spoke with 5 business owners or commercial lenders about potential loans. Additionally, NARCOG held its first ever RLF Bankers Breakfast in partnership with the Decatur-Morgan County Entrepreneurial Center on April 8th. This event has led to an increase in interest in the program, and as of September 30, 2015, one application is awaiting approval. As of September 30, 2015, three (3) loans of the 34 in the portfolio are at least 30 days delinquent."

International Paper - On September 11, 2013, International Paper announced that it would close its Lawrence County plant in early 2014 and lay off approximately 1,100 workers with an annual payroll of \$86M. While International Paper is the largest employer in Lawrence County, the lay-offs will impact 9 North Alabama Counties and the economic impact will ripple and trickle from there. However, Lawrence County will absorb the worst of the blow: Lawrence County will lose approximately \$3.3M in tax revenue, the Town of Courtland will lose approximately \$771K in tax revenue (or nearly half of its annual budget), and the Lawrence County School System will lose approximately \$250K in tax revenue.

Bass Fishing Hall of Fame Museum - In February 2013, Cullman officials announced that they were selected as the site for the Bass Fishing Hall of Fame. The proposed facility will include a 30,900SF hall of fame, and aquarium, gift shop, exhibit space, and a new 56,250SF Cullman Civic Center. The \$17M hall of fame will be developed jointly by the City and County of Cullman on the old Burrow Property of County Road 222 and will be accessed by a new interchange on I-65. Once completed, the new interchange will make this the "[primary gateway" from I-65 to Smith Lake, a major recreational resource and the location of many second homes of the affluent from the surrounding metropolitan areas. The City will own the facility and lease it to the hall of fame organization. This development has the potential to be a huge boon for local, regional, and statewide economic development and tourism.

Alabama Robotics Technology Park (ARTP) - The vision of Governor Riley, this state-of-the-art training center will make Alabama more competitive in economic development efforts and training workers to support our existing high tech and automotive industries. The ARTP is a collaboration between the state, Calhoun Community College, AIDT, and robotics industry leaders. Located on 53 acres across U.S. Highway 31 from Calhoun Community College, the approximately \$73 million ARTP will ultimately include three (3) buildings dedicated to workforce training and research and development. Additionally, the center will employ trainers from some of the top robot suppliers in the world and will be used by major robotics and automation companies for training and product demonstration. Two of the three buildings are already complete and operational. The 1st phase of the robotics park was the "Robotic Maintenance Training

Center", which opened in November 2010. The 2nd phase was the "Advanced Technology Research and Development Center", which opened on August 24, 2011 and will be used by NASA and the U.S. Army Missile Command. The 3rd and final phase will be an "Integration, Entrepreneurial and Paint/Dispense Training Center" open to new robotics companies, as a testing and training facility. Morgan Center Business Park - The Morgan County Industrial Park and Economic Development Cooperative (Morgan County, Decatur, Hartselle, Priceville, Falkville Trinity, Somerville, Eva, and the Decatur-Morgan County Port Authority) issued \$16.7 million in bonds and approved the purchase of 166 acres for the *Morgan Center Business Park* located adjacent to I-65 in Hartselle, Alabama. IX. Integration with Alabama's Economic Development Priorities

In partnership with the AARC Planning Task Force, the NARCOG assisted with the preparation of the *Alabama CEDS* with funding from EDA and in-kind match support from ADECA. All twelve (12) Regions were awarded funding from EDA to update and enhance the previous report by developing benchmarking tools, creating a host website, and establishing a state advisory committee to further support economic development efforts in Alabama. The *Alabama CEDS* was completed in 2012 and is available to view and/or download at http://ceds.alabama.gov/. Additionally, the NARCOG has incorporated elements of *Accelerate Alabama* into the CEDS as appropriate. *Accelerate Alabama* is the state's 3-year strategic plan for economic development unveiled in 2012.

EDA Promotion and Development

X. Regional Vital Priority Projects and Local Projects

2015 Regional Vital Priority "Thematic" Projects Action Plan

The "Regional Vital Priority Projects" identified in 2012 are all "high priority" for the overall economic health of the region. However, by their very nature they are primarily long-term projects. *The CEDS Strategy Committee recognized that the majority of the projects were infrastructure related and decided to group them under six (6) broad "Thematic"* goals as specific objectives to create an "Action Plan" for implementation. IT'S IMPORTANT TO NOTE THAT THESE PROJECTS ARE NOT RANKED IN ORDER.

Goal I: Improve the regional highway transportation system

- a) Widen I-65 from Blount/Cullman County line to Tennessee
- b) Widen Alabama Highway 157 from U.S. 31 to Alabama Highway 69 in Cullman
- c) Widen U.S. 278 from downtown Cullman to Alabama Highway 157
- d) Widen and re-align Alabama Highway 36 from I-65 to U.S. 31 in Hartselle
- e) Support controlled access/capacity improvements on Alabama Highway 20 from I-65 to U.S. 31 in Decatur
- f) Construct Veteran's Parkway (Decatur-Hartselle Bypass)

Goal II: Improve regional rail transportation system

- a) Increase the north/south capacity of the CSX railway
- b) Develop a regional intermodal railyard (inland port) in the Falkville/Lacon/Hanceville area

Goal III: Expand and upgrade regional water and sewer infrastructure

- a) Increase capacity of the WWTP in Hartselle
- b) Support the Duck River Reservoir Project
- c) Explore a 2nd source of potable water for Morgan County

Goal IV: Improve regional air & water transportation service

- a) Pursue & support Folsom Field improvements
- b) Pursue & support Hartselle-Morgan County Regional Airport improvements
- c) Pursue & support Courtland Airbase improvements
- d) Support Decatur Port upgrades
- e) Support Tenn-Tom Waterway improvements

Goal V: Support development of Industrial Parks
