Moulton Parking and Pedestrian Facilities Study

The NARCOG planning staff is currently working on the Downtown Moulton Parking and Pedestrian Facilities Study, a key initiative under our FY2025 Work Program for the Rural Planning Organization (RPO). This study will focus on evaluating and enhancing parking and pedestrian infrastructure in Downtown Moulton, particularly around the historic courthouse square.

We will begin by examining existing conditions, including land use, historic districts and buildings, and planned improvements. This comprehensive anal-

ysis will identify the current state of parking and pedestrian facilities, and provide recommendations to improve connectivity, safety, and the overall pedestrian experience. Ensuring compliance with ADA standards will also be a major focus to make the area accessible to all residents and visitors.

Additionally, we will explore long-term considerations for shared parking, pervious parking surfaces, street edges, infill opportunities, pocket parks, and streetscape enhancements to improve the overall urban de-

sign. These recommendations aim to make downtown Moulton more accessible, walkable, and vibrant, while also preserving its historic charm.

The goal of the study is to provide the City of Moulton and Lawrence County with a tool to guide future decisions about downtown development. The study is expected to be completed by the end of summer, offering actionable recommendations for a thriving downtown.

AGING SERVICES

The Area Agency on Aging is part of a nationwide network of aging services under the direction of the U.S. Administration for Community Living and is funded through the Alabama Department of Senior Services (ADSS). This partnership with ADSS, working under the authority of the Older Americans Act, is to plan and carry out a comprehensive, coordinated service delivery system to address the needs of people over 60, or persons with disabilities of any age, and help them maintain their independence. The NARCOG Transit Agency operates an urban public transportation system within the Decatur Urban Area. The purpose of this service is to provide mobility opportunities to individuals of all ages and abilities in collaboration with the City of Decatur and the Federal Transit Administration.

- Wheelchair-accessible vehicles are available
- Each one-way ride costs \$2
- Connect Cards (prepaid punch cards) can be purchased at the main office or on a transit vehicle for \$20
- Ride Operations are Monday through Friday from 7 AM to 5 PM
- Ride Scheduling is Monday through Friday from 7:30 AM to 4 PM
