### **Senior Farmers Market Nutrition Program**



The Senior Farmers Market Nutrition Program (SFMNP) applications are now open! SFMNP is a valuable program offering eligible seniors the opportunity to purchase fresh produce from local farmers' markets. This program allows seniors to acquire fresh fruits, vegetables, cut herbs, and locally harvested honey.

Participating seniors will receive a one-time benefit worth \$50, which can be utilized across multiple visits until the balance reaches zero. The yearly, one-time \$50 benefit is added to a reloadable card, similar to a debit card. If possible, reapplying seniors are encouraged to have their benefit cards from the previous year on hand. It's important to note that the benefit card is exclusive to farmers' markets and cannot be redeemed at commercial grocery stores.

# 2024 Washington Update

NARCOG Directors recently attended the Decatur-Morgan County Chamber of Commerce's 2024 Washington Update, held at the DoubleTree by Hilton on January 23. This informative session explored Alabama's advancements and prospects across critical domains such as education, economic development, infrastructure, and more, all within the context of the business community.

Morgan County Commission Chairman Ray Long introduced Congressman Dale Strong to the sizable audience. Wade Weaver took on the moderator role, asking Congressman Strong about a dozen questions.

# **Current Job Opportunities**

NARCOG is currently looking for Part-Time Drivers and a Transportation Operations Manager for the Transit Office.

Part-Time Drivers will provide public transportation services for individuals in the Decatur area. The position is responsible for the safe operation of NARGOG Transit vehicles and transporting passengers over a specified route to local and distant points according to transit schedules. Responsibilities include picking up passengers in Decatur and transporting them to requested locations in Decatur, assisting wheelchair passengers on and off vehicle lifts, securement of wheelchair or motorized chair passengers, pushing and lifting wheelchairs when necessary, and carrying a passenger's medical equipment.

The Transportation Operations Manager plans and directs the operations of NARCOG Transit by providing safe and reliable transportation to the citizens of the service area. This employee will assist with grant applications and the annual budget, manage personnel matters, negotiate services, and arrange for vehicles to be maintained and repaired. This position also monitors the execution of public transportation, contract routes, and demand response routes that provide transportation for low-income individuals and individuals with disabilities.
