2023 Masters Games Competition



Over the month of June, adults 50 and older participated in the District Events of the Masters Games of Alabama. Masters Games of Alabama is a non-profit organization dedicated to promoting healthy lifestyles through social and physical activities.

These games provide older adults days of fun and fellowship, with a sprinkle of competition.

District Two events invited older adults from Cullman, DeKalb, Jackson, Lawrence, Limestone, Madison, Marshall, and Morgan Counties to play



recreational games. Registration was required by May 30 to begin competing on June 14.

Games included Domino doubles, Domino singles, basketball free throw, cornhole, pickleball doubles, pickleball mixed doubles, softball throw, shuffleboard, Nerf throw, frisbee throw, Rook, table tennis, bowling, billiards, 5k walk/run, 3-on-3 basketball, golf singles, and 2-man scramble.

Masters Games offers many game options to include anyone who wants to attend while also splitting people up into age ranges for fair competition. All



events are split into nine age groups, each containing up to a five-year age difference (i.e., 50-54, 55-59, etc.). In partnered events, the age of the younger player is the age group you will play in.

Each event received first, second, and third-place players. Players who place have an opportunity to play at the State Games in October.

NARCOG celebrates older adults getting up and active, and values getting to partner with like-minded agencies to help run District Events of the Masters Games of Alabama.


Lawrence County Awarded \$1.5 Million

Lawrence County has been awarded \$1.5 million in Community Development Block Grant (CDBG) funds to support a solar energy project by Governor Kay Ivey.

First Solar Inc. will produce solar panels and create 715 jobs for Lawrence County. The CDBG funds will help provide infrastructure along with sewer, water, and street improvements to the Mallard Fox West Industrial Complex, where the plant will be constructed.

Alabama Department of Economic and Community Affairs (ADECA) Director Kenneth Boswell said, "ADECA is pleased to join Gov. Ivey in support of this project which will have a tremendous impact in north Alabama and particularly Lawrence County, which suffered a severe blow several years ago when one of its largest employers, International Paper Co. plant, shutdown."

The NARCOG Planning and Economic Development team helped prepare the grant application, while ADECA will administer the funds. The plant is expected to begin solar panel production in 2025.

TRIO Wins Senior Meals Contract

The Elderly Nutrition Program (ENP), supported by the Alabama Department of Senior Services (ADSS), provides adults 60 and older with nutritious meals at their local senior center. Homebound individuals may be eligible for a meal delivery program. ENP offers hot, healthy lunch Monday through Friday, apart from holidays, at no cost.

Starting July 1, 2023, TRIO Community Meals (TRIO) will begin a five-year contract to provide meals to approximately 330 senior centers around Alabama. In Cullman, Lawrence, and Morgan County, they are currently 22 senior centers that will enjoy TRIO meals.

TRIO is an Elior North America company with over 50 years of experience providing meals. TRIO delivers over 2.5 million meals weekly throughout the United States.

In Fiscal Year 2022, more than 5 million congregate, curbside, and home-delivered meals were provided throughout Alabama.

ADSS Commissioner Jean Brown commented that "this contract is the result of months of planning and development by ADSS staff who are mindful that our partnership with TRIO will ensure that senior meals are tasty, nutritionally balanced, and wholesome.

"The importance of the ENP can't be overstated. In some cases, it may provide the only balanced meal a senior eats that day. Those meals are also an essential part of allowing seniors to stay in their homes."

NARCOG looks forward to work-

ing closely with TRIO to give older adults in the Region delicious, nutritious meals.

Senior Community Service Employment Program

The primary mission of NARCOG is to positively impact people and communities. NARCOG partners with the Center of Workforce Inclusion to provide work through the Senior Community Service Employment Program (SCSEP).

Authorized by the Older Americans Act, SCSEP provides on-thejob training to people 55 and older with incomes at or below 125% of the federal poverty level. This is a work-based job training program for older Americans, helping them build skills and confidence to begin searching for employment outside of SCSEP.

Participant's assignments are coordinated with a public facility or non-profit 501(c)(3) agency such as schools, libraries, museums, and senior centers.

SCSEP participants receive paid training for approximately 19 hours a week at the highest rate of federal, state, or local minimum wage. They receive on-the-job training, learn new skills, update previous skills, and get work experience that prepares them to reenter the workforce.

"The SCSEP Program can help

our older adults regain their confidence, give them a daily purpose by allowing them to get out of the home environment, gain or refresh work skills and make new friends along the way. The pay may sometimes seem minimal to others but can be a monumental help to those in a time of need," SCSEP Coordinator Daffney Harris remarks.

Hospital to Home Transition

NARCOG recently added a new position under the Medicaid Waiver Program, a Hospital to Home (H2H) Transition Coordinator. Brittany Yarbrough, initially a NARCOG Case Manager, was promoted to the H2H Transition Coordinator position.

The goal of the H2H program is to help older adults and individuals with disabilities return to the community and remain in the community safely while reducing long-term placement and re-hospitalization.

The primary responsibilities of this job include:

• Working with acute care facilities, Aging and Disability Resource Centers, and other community-based organizations to help with transitions.

• Enrolling eligible individuals admitted to an acute care facility and helping them return to their homes with Medicaid Waiver services.

• Public outreach to individuals unaware of this program.

"I am very excited and honored to help build this program with NARCOG and provide services to the communities we serve," Yarbrough said. "I believe this program can, and will, benefit the individuals in Cullman, Lawrence, and Morgan counties. I look forward to serving these populations of the elderly and disabled and helping these individuals have their needs met while living safely in the community among family and friends."

Eligibility for this program requires full Alabama Medicaid coverage, being medically eligible for long-term care placement, not receiving Home and Community-Based Services (HCBS) through a waiver program, having safe and affordable housing to return to, and having a willing and able caregiver. H2H services begin as soon as the qualifying individual is discharged home and are life-long as long as they remain eligible.
